RECOGNITION OF ORGANIZER'S CONDITIONS • ACCEPTATION DES CONDITIONS

With the submission of this entry, the rider/horse owner accepts all show conditions and regulations the rulebook of the NRHA and the medication regulations and insurances. The horse's ID paper (horse passport) and an additional health certificate for foreign competitors must be presented at the show office. Signing the entry form confirm that the horse is free of contagious diseases and that a third party insurance has been taken for riders, owners and horses. The rider commits himself to pay the entry and stable fees, even if the event of his withdrawal with just cause. Changes in bookings and entries may only be made through the show office. Rider/horse owner will follow all instructions by the show management. All decisions made by the show management are binding and final. Incomplete or unsigned participation requests or those without deposits will not be considered or processed.

En remplissant et en signant le formulaire, le cavalier et le propriétaire du cheval reconnaissent et acceptent toutes les règles et conditions du show, les conditions du Rulebook de la NRHA, ainsi que les règles liées à la médication et aux assurances. Le papier d'identité du cheval (passeport du cheval) et un certificat de santé supplémentaire pour les concurrents étrangers doivent être présentés au ShowOffice. En signant le formulaire d'engagement, le responsable du cheval confirme que le cheval n'a pas de maladie contagieuse, et qu'il bénéficie d'une assurance en responsabilité civile pour lui-même et son cheval. Le cavalier s'engage à payer son entrée, même en cas de retrait qu'elle qu'en soit la cause. Les modifications de réservation/inscriptions ne peuvent se faire que par le biais du show office. Les cavaliers et propriétaires suivront toutes les instructions du show management. Toutes les décisions prises par le show management sont obligatoires et définitives. Les demandes de participation incomplètes, non signées ou sans acompte ne seront pas prises en considération

PROFESSIONAL LIABILITY & PROPERTY DAMAGE INSURANCE POLICIES • ASSURANCE RESPONSABILITE CIVILE & DOMMAGE MATERIEL

The insurance of the horse / rider / horse owner /grooms or guardian/ breeder (civil liability) is mandatory; it should be contracted directly with your insurer. Valid personal insurance for people and horses is compulsory: civil liability, automobile, individual accident, disease, multiple risks, mortality, etc. A copy must be attached to the participation request in order for it to be validated. Horses are accommodated in temporary or permanent stables. The Organizing Committee declines all responsibility in the event of an accident or losses. The rider / horse owner /grooms or guardian/ breeder alone are responsible for their own equidae from their arrival at the competition, inside and outside of the boxes, before, during and after their presentation/show. Rider / horse owner /grooms or guardian/ breeder is aware of that they are personally liable of any damages caused by the horse if there is no liability insurance. The horse owner shall indemnify and hold harmless show organizer against any claims or legal proceedings brought by third parties. Rider/horse owner will be responsible for any damages occurring in the stalls, paddocks, walker or anywhere in the BO RANCH facilities and they are liable of any damages caused by the horse or any people in charge of the horse.

L'assurance du cheval / cavalier / propriétaire / groom ou gardien d'équidés / éleveur (responsabilité civile...) est obligatoire, elle doit être contractée directement auprès de votre assureur. Assurances personnelles pour les personnes et les chevaux en cours de validité obligatoires : responsabilité civile, automobile, individuelle accident, maladie, tous risques, de mortalité, etc. Une copie doit être jointe à la demande de participation pour validation. Les chevaux sont logés dans des boxes permanents ou temporaires. Le Comité Organisateur décline toute responsabilité en cas d'accident ou de vol. Les cavaliers/ propriétaires d'équidés / grooms ou gardiens d'équidés / éleveurs sont seuls responsables de leurs équidés dès leur arrivée sur la compétition, à l'intérieur et à l'extérieur des boxes, avant, pendant et après les passages en carrière. Les cavaliers / propriétaires d'équidés / grooms ou gardiens d'équidés / éleveurs sont seuls responsables pour tous les dégâts aux installations dans son box, au paddock, au marcheur, à l'intérieur des installations BO RANCH, aux aménagements, occasionnés par son cheval, par lui-même ou par une personne engagée à s'occuper de son cheval.

The horse owner shall indemnify and hold harmless show organizer against any claims or legal proceedings brought by third parties. The horse rider / horse owner alone will be liable, both criminally and civilly, for any consequences of failure to obtain authorization, and no claim may be made in liability against the Organizer for any reason whatsoever. On the other hand, it undertakes to discharge and guarantee the Organizer against any losses or damage resulting from failure to comply with the aforementioned provisions.

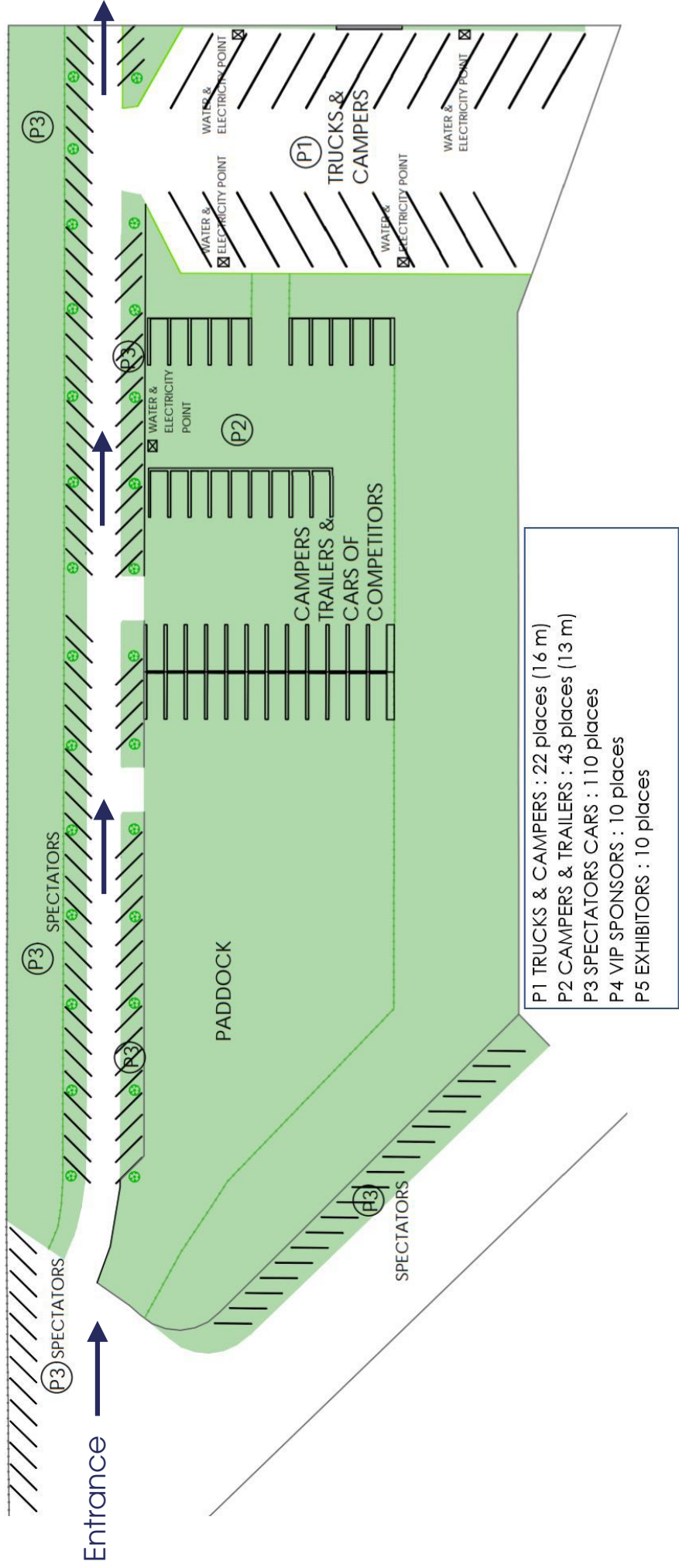

The organizer reserves the right to change the conditions up to the entry deadline, postpone or cancel the event on his sole decision, the competitor is not being entitled to claim any compensation in that respect. Under the provisions of article 1218 of the French Civil Code, the Parties' obligations will be suspended in the event of a case of force majeure. By express agreement, the following events inter alia are deemed cases of force majeure: (i) war, riots, fire, strikes, natural disasters, shortages of raw materials, transport strikes, human or animal epidemics, withdrawal or suspension of federal authorizations and/or health authorities, administrative closure of the site by a competent authority vested with the necessary security or policing powers, even if the statutory and case-law conditions of force majeure are not met; (ii) proven threat of terrorism or of commission of an act of terrorism. The Party that is the victim of an event of Force Majeure shall alert the other Party forthwith by registered letter with acknowledgement of receipt immediately upon occurrence of said event, and performance of its obligations will thus be suspended.

The treatment of horses with foreign substances or drugs, that are not allowed according to the doping laws of the FEI and/or the country of France are prohibited. All horses are subject to testing

YOUTH • MINEURS

All minors are obliged to wear a correctly regulated skull protection which conforms with equestrian standards, a helmet or riding hat, while riding in the facility. The chin strap must be adjusted and attached. All other protections adapted to equestrian events are authorized under the rider's responsibility. For the Youth classes, riders aged 18 or under have to wear a helmet.

Une protection individuelle céphalique ajustée, répondant aux normes équestres en vigueur, et plus communément dénommée casque ou bombe, est obligatoire pour tout mineur à cheval dans l'enceinte du concours. 4. Owners may enter more than one horse. Riders may ride no more than three horses per Futurity class.
5. **Entry deadline : May 2nd 2022.** Entries by online-inscriptions and/or mail shall be binding. Entries and stable reservations will not be handled before receipt of payment.
6. **By submitting the entry form rider/horse owner accepts all show conditions and regulations and the 2022 NRHA Rules and Regulation. Rider/horse owner will follow all instructions by the show management. All decisions made by the show management are binding and final.**

7. PARTICIPATION

Entries will not be considered unless forms are completely filled in and received by the organizer in due time, accompanied by horse documentation (AQHA, APHA, etc.) including NRHA Competition License, a copy of the valid NRHA Membership Card (rider and owner), and evidence of payment of all fees. Permission to participate will not be granted unless a valid NRHA Membership Card is provided latest on the day of the event, regardless if a NRHA Membership Card exists and is valid at the time of the event. Rider/horse owner assures that the horse(s) is free of any contagious diseases, properly vaccinated and carries public liability insurance at the time the horse arrives at the showgrounds. **Rider/horse owner has accepted all Insurance conditions and a copy if the insurance will be given to the showoffice.**

8. PAYMENT OF FEES

Complete payment information will be included on the entry form. It is the owner's responsibility to make the entry on before the due date. Show Management will not be responsible for entries not received by the due date or lost in the mail. Failure to pay applies to the rider, owner, or agent for any unpaid debts, related to the entry, exhibition, showing, stalling, or any related fee of an entry at an approved NRHA event. Agent is defined as anyone who acts and/or signs on the behalf of an owner or rider (see General Rules and Regulations, F. Failure to pay in the current NRHA Handbook).

9. SUBSTITUTION/TRANSFERS BETWEEN FUTURITIES

Substitutions of horses/entries will be permitted after entry deadline but must be completed before 5pm two days prior to the first go-round, a penalty of 20% of the entry fee will apply.

Late entries at the show may or may not be accepted dependent upon the scheduled time allotted.

An entry may transfer from the Open to Non Pro Futurity after entry deadline but must be completed before 5pm two days prior to the first go-round. That entry will then be placed in a group to precede the regular draw in the reverse order that they were received. The Open Futurity entry fee will be refund ; the Non Pro Futurity entry fee with a penalty of 20% must be payed. All entry payments will be applied to Non Pro Futurity entry fees.

An entry may transfer from the Non Pro to Open Futurity after entry deadline but must be completed before 5pm two days prior to the first go-round. That entry will then be placed in a group to precede the regular draw in the reverse order that they were received. 12. SHOW RETAINAGE

The Show retainage for the Futurity will be 50%, in addition to the standard 5% NRHA show fee deduction.

13. CHANGE OF OWNERSHIP

An entered horse may change ownership and retain entry status under the new owner provided that the transfer of the NRHA competition license is complete and the new owner is a member of the National Reining Horse Association. If entered into the Non Pro the rider must follow the Non Pro rules as provided in the NRHA Handbook. Changes may not be made during the go-round.

14. PAYEE

All results will be recorded in USD in the NRHA database. If payouts are made in euros, they will be converted to USD using the conversion rate set by NRHA as of January 1 of the applicable year. Prize money will be paid to the owner as recorded in the NRHA database at the start of the event. The prize money will be paid by bank transfer to the bank account of the Recipient of Payback, as filled in the entry form. Recipient of Invoice is responsible to provide the correct information for bank transfer. Taxes may be deducted as national laws dictate. If the horse is transferred during the show, the previous owner and the new owner must complete an Authorization of Prize Money Payment Form.

15. CONVERSION RATE

The Euro-US dollars exchange rate for payback calculation is 1,13691 (January 1st 2022)

16. RIDERS

Rider for horses entered in the Open Futurity must be designated no later than entry deadline. If the Rider Designation is not received by entry deadline, the rider will be indicated as "Rider Not Designated" and NRHA is not responsible for draw positions closer than the conditions specify. In the Open draw, NRHA will attempt to separate horses with a common rider by at least fifteen (15) horses or highest number possible. In the Non Pro draw, NRHA will attempt to separate horses with a common rider or owner by at least fifteen (15) horses or highest number possible.

17. JUDGES

There will be five judges placed at different points in the arena: the high score and the low score will be eliminated with only the total of the remaining three scores used to determine the final score. There will be an equipment judge at a pre-check, and a judge's monitor present for the duration of the Futurity classes.

18. **JUDGES FEES** The Judges fee is due at the time entry is made.

19. CONDITION CHANGES

These rules and conditions are subject to change by action of the European Executive Board, European Council or the NRHA Board of Directors. The NRHA Board of Directors reserves the right to interpret, modify or amend conditions for the NRHA European Futurity. If requiring immediate attention, those rights will be deferred to the European Executive Board.

20. RIGHT TO CANCEL

Entries are received subject to the right of NRHA European Council to refuse the entry, or a transfer of the entry, without notice to the subscriber. Acceptance of the entry is based on the representations made on the entry form. Decisions of the Executive Committee will be final. Riders are responsible to know and adhere to eligibility requirements for NRHA events. A rider who enters an event or division in which he/she is ineligible, will forfeit all winnings and entry fees to the NRHA, and be subjected to disciplinary action by the NRHA Board of Directors for unsportsmanlike conduct as set forth in the current NRHA Handbook. 21. DISCIPLINE

Show management reserves the right to discipline any person that it concludes has abused or permitted abusive behavior against a horse, or engaged in unsportsmanlike conduct toward show management, judges or exhibitors. 22. ELIGIBILITY

All riders with the exception of those who wish to enter the Level 1 only will be entered into the levels they are eligible for in the Futurity (exception if there are additional divisions such as youth, prime time, masters, etc. of which will need to be entered separately). In all classes, a rider who enters an event or division in which he/she is ineligible, will forfeit all winnings and entry fees, and will be subjected to fines as set forth in the current NRHA Handbook. The rider is responsible for the entry information regardless of whether the form is completed by the agent or owner. The Restricted European Eligibility will apply for all Category 6 Futurity classes.

23. TIES

In the event of a tie in a final, the tie-breaking procedures as outlined in the current year NRHA Handbook will be used to break the tie

24. RIBBON PRESENTATION

Prize money will be paid only if the rider shows up at the ribbons presentation in show outfit and ON horse.

All horses entered in the NRHA European Futurity are subject to examination. It is not NRHA's intention to conflict with rules and regulations of states, provinces or countries in regard to medications. In cases, where NRHA shows are held in states, provinces or countries with medications rules and regulations, the rules and regulations of the state, province or country take precedence. Any member who acts or is associated with someone who acts in a way towards NRHA testing teams that is deemed inappropriate will have an Unsportsmanlike Protest filed against them with NRHA.
